Personnel Committee Report - Sara Henley

The Personnel Committee met prior to the board meeting and the following recommendations were brought forward.

Mrs. Henley motioned to approve the Three Rivers SWCD FY24 Annual Plan of Work and the Desktop Procedures for District Fiscal Operations adopted by the VA Soil and Water Board on June 24, 2022 to be used for FY24 District Operations. Mr. Townsend seconded the motion and the motioned carried.

Mrs. Henley motioned to enter into an agreement with Gallagher Risk Management and Consulting (Charlotte Jenson) to perform a human resources audit. Mr. Fox seconded the motion and the motion carried.

Finance Committee Report - Keith Balderson

The Finance Committee met prior to the board meeting and the following recommendation was brought forward.

Mr. Balderson – Finance Committee Chair motioned to approve the FY24 Itemized District Operations & Cost Share Budget as presented. Mr. Taylor seconded the motion and the motion carried. (Report Attached)

Agricultural Committee Report - Keith Balderson, Sarah Cole & Waring Baylor

Ms. Cole stated the original grant funding of \$4,479,901.00 plus the additional \$2,265,522.13 requested from DCR resulted in a total of \$6,745,423.13 funds received. After paying all outstanding contracts, there will be a remainder of \$78,565.84. This means the District was able to spend 100% of the original allocation as well as an additional 96.5% of the additional funding received. The remaining funds will be returned to DCR following protocol. Next year's budget of \$6,189,089.00.

<u>Agricultural Committee Report – Keith Balderson, Sarah Cole & Waring Baylor Cont.</u> Mr. Baylor stated he performed 59 spot checks with Marissa Roland of DCR between Monday, June 12 and Wednesday, June 14. All the checks performed were found to be in compliance.

The Agricultural Committee met prior to the board meeting and the following recommendations were brought forward.

Mr. Balderson stated the Ag Committee reviewed and discussed the proposed Secondary Considerations and Average Cost List for FY 24. Mr. Balderson made a motion to approve the Secondary Considerations and Average Cost List for FY 24 as presented. Mr. Longest seconded the motion. The motion carried. (Report Attached)

With the availability of funding, four new no-till contracts were presented for approval. Contract 43-23-0315 is a CCI-CNT contract totaling \$3,187.50. Contract 43-23-0316 is a SL-15A contract totaling \$13,265.00. Contract 43-23-0317 is a CCI-CNT contract totaling \$3,318.00. Contract 43-23-0318 is a SL-15A contract totaling \$3,985.00. Mr. Balderson made a motion to approve the contracts as presented. Mr. Townsend seconded the motion. The motion carried. (Report Attached)

Mr. Balderson advised the Ag Committee was also presented with a potential Memorandum of Understanding from Jim Wallace of Colonial SWCD regarding the VCAP Program. Mr. Balderson suggested that the matter be tabled for discussion at the July Board meeting.
